- Degree Audit—required every semester (Non-Pathways Only)
- Request for Certification—required every semester
- Certificate of Eligibility –Everyone EXCEPT Chapter 31
- DD214--for all <u>EXCEPT</u> Chapter 1606 and Chapter 35
- NOBE—Only for Chapter 1606
