



## POLICY STATEMENT 42 TOBACCO POLICY

### POLICY DIGEST

Monitoring Unit: Chancellor's Office

### I. PURPOSE

The use of tobacco products is harmful to health and imposes costs on LSU Eunice and all members of the LSU Eunice community. State law [RS 40:1291.23](#) requires LSU Eunice to adopt a smoke-free policy and authorizes LSU Eunice to adopt a tobacco-free policy. This policy is intended to comply with State law and to balance the individual liberty of members of the LSU Eunice community with concern for the significant negative health effects of tobacco use, the costs associated with campus facilities administration, and LSU Eunice's ability to recruit students, faculty, and staff.

### II. DEFINITIONS

**LSU Eunice Campus:** all land, property, buildings, and other facilities owned, leased, or otherwise controlled by LSU Eunice. This includes any land, property, buildings, and other facilities that may be leased by LSU Eunice to private third parties, such as Bengal Village, affiliated foundations, or others.

**Smoking:** inhaling, exhaling, burning, carrying, or possessing any lighted tobacco product, including cigarettes, cigars, pipe tobacco, and any other lighted combustible plant material; it also means the use of electronic cigarettes and any other product that is used to deliver nicotine by means of smoke or vapor.

**Tobacco Products:** any and all forms of tobacco, including but not limited to cigarettes, cigars, pipes, water pipes (hookah), bidis, kreteks, smokeless tobacco, snuff, and chewing tobacco, as well as electronic cigarettes and any other product which is used to deliver nicotine by means of smoke or vapor. This does not include any FDA-approved product or device intended to assist the user to stop smoking or using tobacco products.

### III. GENERAL POLICY

Smoking and the use of all tobacco products on the LSU Eunice Campus is prohibited. This prohibition applies to all individuals while on the LSU Eunice Campus, including faculty, staff, students, administrators, contractors, and visitors.

### IV. PROCEDURES

A. Exceptions to the prohibition of smoking and the use of other tobacco products are

41 authorized as follows:

- 42 1. Research involving tobacco products, provided the university employee obtains the  
43 prior approval of the Chancellor and the Vice Chancellor for Academic Affairs and  
44 Provost. Smoke, like any other laboratory air contaminant, shall be controlled and  
45 subject to any applicable health and safety standards.
- 46 2. By artists or actors who participate in university authorized performances that require  
47 tobacco use as part of the artistic production.
- 48 3. Educational, clinical, or other appropriate purposes with prior approval of the dean or  
49 director responsible for the facility as well as the Vice Chancellor for Academic Affairs  
50 and Provost.

## 51 B. Enforcement

52 Effective implementation of this policy relies on the courtesy, respect, and cooperation of all  
53 members of the university community. It is expected that all members of the LSU Eunice  
54 community will comply with the policy voluntarily. For those who do not, punitive sanctions  
55 should not be imposed until other efforts, such as verbally addressing the issue with the  
56 tobacco user or formal warnings of potential disciplinary action, have failed.

- 57 1. A single violation of this policy shall not itself be cause for discipline to students, faculty,  
58 or staff. Repeated violations of this policy, after discussions with the tobacco user by an  
59 appropriate University official and as appropriate, formal warnings against repeated  
60 violations, may be grounds for discipline.
- 61 2. If someone is seen using tobacco products on the LSU Eunice Campus, any member  
62 of the university community may inform the tobacco user of this policy and request that  
63 he or she comply. If the user does not comply or if the individual prefers not to directly  
64 confront the user, details of the policy violation may be brought to the attention of the  
65 appropriate university official responsible for the tobacco user as shown below.
  - 66 a. For faculty members, the faculty member's department dean.
  - 67 b. For staff, the employee's supervisor or the Office of Human Resource Management.
  - 68 c. For students, the Office of Student Affairs.
  - 69 d. For contractors, the Director of the Facility Services, or a designee of the office, or  
70 to the head of the office for which the contractor is providing services.
  - 71 e. Where the status of the tobacco user is unknown, the matter may be brought to the  
72 attention of any appropriate university official.
- 73 3. The official to whom the violation is referred will take action as he or she deems  
74 appropriate under the circumstances. This may include, but is not limited to, discussing  
75 the matter with the tobacco user immediately, issuing a warning letter notifying the user  
76 about the policy, requiring the user to meet with appropriate university officials for  
77 additional conversations, or for repeated violations, impose appropriate disciplinary  
78 sanctions for repeated refusal to comply with university policy.

79 C. Notifications and Signage

80 Ashtrays are no longer provided on the LSU Eunice Campus. All ashtrays are to be  
81 removed, covered, or otherwise made unusable by the Facilities Services. Campus signage  
82 shall be developed and implemented to inform students, faculty, staff, administrators,  
83 contractors, and visitors that LSU Eunice is a tobacco-free campus and cessation  
84 resources are available. Unit heads must convey information about this policy to their  
85 faculty and staff as appropriate.

86 D. Cessation Assistance

87 The university is committed to supporting all students and employees who wish to stop  
88 using tobacco products; and assistance is available. For a listing of tobacco cessation
